3	Member	MOFR and other government agencies, research institute (SINU), donor agencies and their funded projects, NGOs, CBOs, Private companies, and Women Rep in Forest Sector
4	Role of Secretariat	Responsible for logistical arrangements, attendance confirmation, preparation of agenda, note taking and managing mailing group of FS-TWG








